1. INTRODUCTION AND DATA CONTROLLER

We care about your privacy. This document describes how we process your data in accordance with the GDPR (General Data Protection Regulation).

2. PURPOSES AND LEGAL BASIS FOR PROCESSING

We process personal data for the following purposes:

- **Order Fulfillment (Art. 6(1)(b) GDPR):** Managing the purchase of PDF/DXF files and machines.
- **Payment Processing:** Transferring data to **Tpay** and **Stripe** to finalize transactions.
- **Analytics (Google Analytics):** Analyzing website traffic to improve the service.
- **Social Media:** Managing interactions on YouTube, Facebook, and Instagram profiles.
- **Security:** Server logs (IP, session time) processed to protect the website.

3. DATA RECIPIENTS

We only transfer your data to trusted partners necessary for the store's operation:

- **EasyCart** (sales system),
- **Krajowa Integracja Płatnicza S.A. (Tpay)** and **Stripe** (payment processing),
- IT and hosting service providers,
- Courier companies (for physical product shipping).

4. YOUR RIGHTS

You have the right to: access your data, rectify it, erase it, restrict processing, data portability, and object to processing. You also have the right to lodge a complaint with the President of the Personal Data Protection Office (UODO).
